Sir/Madam,

I am to state that the next Assistant Accounts Officer (Civil) Examination is likely to be held in the last week of December, 2017 at Ahmedabad, Bangalore, Chennai, Delhi, Hyderabad, Jaipur, Kavarati, Kolkata, Lucknow, Mumbai, Nagpur, Patna, Port Blair & Shillong. Centres may be added or deleted depending upon administrative convenience and the number of candidates taking the examination at a centre. Candidates must necessarily take the examination at the venue located at the place of their posting, if there is one. Otherwise, they will be allocated a centre nearest to their place of posting.

- 2. A statement showing the list of existing candidates of your organisation who had registered for the examinations conducted earlier but could not clear it so far is enclosed. The list of existing candidates includes those candidates who had appeared in the AAO (Civil) Examination conducted in October 2014 and also those who have appeared in the reexamination conducted in July this year. Since the status of the 2014 exam will be clear only after the Writ Petitions No.5653/2017 and 5654/2017 are disposed off by the Hon'ble Delhi High Court, the papers passed by the candidates in the said examination has been left blank. The Papers passed in examinations conducted prior to 2014 have been indicated with the letter "P", and the Paper(s) which the candidates are yet to pass has/have been left blank. The blank spaces may be filled up with the letters "Y" or "N", as the case may be, "Y" for willingness to appear in the Paper and "N" for unwillingness. This statement may be returned to this office in original, duly authenticated by the Pr.CCA/CCA/CA after indicating the options of the candidates as mentioned above. Omissions, if any, of the existing candidates may please be intimated to this office along with relevant particulars of the candidates.
- 3. All eligible candidates may be advised to apply for appearing in the examination. Seniority of the successful candidates of the AAO (Civil) Examination 2017 will be subject to the outcome of Writ Petitions No.5653/2017 and 5654/2017 pending before the Hon'ble High Court of Delhi.
- 4. The list of all eligible candidates who fulfil the eligibility conditions prescribed in Para 4 of the Regulations of the AAO (Civil) Examination 2006 and who are applying for the first time may be furnished in the prescribed proforma AAE-12 (specimen enclosed). The candidates will be permitted to appear only in those papers which they opt to appear in. Option once exercised will be final. In the case of Accountants who joined CCAS on

deputation basis and were subsequently absorbed into the service, the required minimum service of 3 years will be counted from the date they joined the CCAS on deputation basis. However, they will be eligible to appear in the examination only if they have passed the Confirmatory Examination for Accountants.

- 5. A consolidated list of candidates who have secured exemptions in terms of Para 7 read with Corrigendum No.1 (copy enclosed) and Para 8 of the Regulations of the AAO (Civil) Examination 2006, showing the name of the candidate, subject(s) in which exemption granted, Index No. and year of the relevant exams must be submitted in a separate Annexure.
- 6. The list of candidates may be sent to this office <u>latest by 15th October, 2017</u>. <u>The list in Excel Format may also please be mailed to pariksha-cga@gov. in</u>
- 7. The final list of candidates showing the Index Nos. allotted for Assistant Accounts Officer (Civil) Examination 2017 and centers of examination etc. would be sent by this office.
- 8. A reference is invited to Para 5 of the regulations which provides that no request for relaxation of any conditions of eligibility shall be entertained by the Controller General of Accounts. No such request or recommendation for relaxation of the conditions of eligibility need, therefore, be sent to this office.
- 9. Applications for withdrawal from the examination will be regulated in accordance with Para 6 of the Assistant Accounts Officer (Civil) Examination Regulations 2006. The last date up to which the candidates will be allowed to withdraw their candidature will be <u>06.11.2017</u> and the list of such candidates who have been allowed to withdraw their candidature should be forwarded to this office by <u>13.11.2017</u>. These dates may please be strictly adhered to.
- 10. The pattern, syllabus and mode of conduct of AAO (Civil) Examination may undergo changes w.e.f the year 2018. All prospective candidates of your Ministry/Department may, therefore, be encouraged to take part in the AAO (Civil) Examination, 2017.
- 11. In order to be declared successful in the AAO (Civil) Examination, 2017, candidates will have to undergo the required training and pass the CCC Exam conducted by NIELIT before the commencement of AAO (Civil) Examination, 2017.
- 12. Detailed time table of the examination will follow in due course.

Corrigendum No. 1 to the "Regulation for the Junior Accounts Officer (Civil) Examination for the Appointment as Junior Accounts Officer in Departmentalised Accounts Organisation effective from 2006".

The following may be read as against the exiting provisions of Rule 7: Results/Pass Marks.

"A candidate who has passed all 8 papers and also qualifies the examination on Computers will be declared as passed and will be eligible for promotion as Junior Accounts Officer. In order to pass in a Paper a candidate should secure a minimum of 50% marks, where upon he/she will also be exempt from reappearing in that paper. For SC/ST candidates the pass mark will be 45%".
