**OFFICE MEMORANDUM**

**Subject: Issue of appointment letter/joining of passed candidates of Combined Higher Secondary level Examination, 2016 (SSC) for the post of LDC in CCAS under CGA.**

Attention is invited to this office's O.M. of even No. (97) dated 10.05.2018 regarding issue of centralized offer of appointment to the CHSLE-2016 (SSC) passed candidates and subsequent O.M. (431) dated 11.09.2018 requesting therein to furnish report on issue of appointment letters / joining of candidates to the post of LDC on direct recruitment basis.


On the basis of joining reports received in this office, it has been observed that 27 candidates of CHSLE-2016 (list annexed herewith) have not joined as LDC till date due to one or other reasons as specified by the concerned Ministries/Departments.

The centralized offer of appointment was issued to CHSLE-2016 passed candidates on 10.05.2018 (the centralized offer of appointment was also forwarded to each candidate separately). As per DoPT O.M. No. 35015/2/93-Estt(D) dated 09.08.1995, an offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment i.e in this case offer of appointment shall be deemed as cancelled automatically on 09.11.2018 in respect of candidates who failed to join the post within stipulated time. Further, DoPT vide O.M. No. 1259494-Estt.(D) dated 09.08.2017 has advised for strict compliance of the instructions contained in aforesaid O.M. dated 09.08.1995.

The concerned Pr.CCAs/CCAs/CAs are, therefore, requested to not to grant any extension of joining time further and to ensure that the remaining candidates shall join the post of LDC well before 09.11.2018 or otherwise the offer of appointment to the candidate shall be deemed as cancelled automatically and no further communication will be entertained in this regard.

The Ministries/Departments shall issue cancellation order in respect of each candidate who failed to join the post upto 09.11.2018, after ensuring completion of all formalities including issue of offer of appointment followed by reminder(s) separately in each case, under intimation to this office. The reminder(s) shall be issued well before 09.11.2018 specifying the last date of joining not later than 09.11.2018 in any case. The dossiers of candidates whose offer of appointment cancelled, shall be forwarded to this office upto 20.11.2018 positively alongwith copy of correspondence with candidate (Copy of Appointment letter, Reminders and Candidature cancellation order) for onward forwarding to SSC.
