## **OFFICE MEMORANDUM**

Subject:

Issue of appointment letter/joining of passed candidates of Combined Graduate level Examination, 2016 (SSC) for the post of Accountant in CCAS under CGA – reg.

Attention is invited to this office's O.M. of even No. (668) dated 28.02.2018 regarding issue of centralized offer of appointment to the CGLE-2016 (SSC) passed candidates and subsequent O.M. (237) dated 04.07.2018 requesting therein to furnish report on issue of appointment letters / joining of candidates to the post of Accountant on direct recruitment basis.

On the basis of joining reports received in this office, it has been observed that 22 candidates of CGLE-2016 (list annexed herewith) have not joined as Accountant till date due to one or other reasons as specified by the concerned ministries/departments.

According to DOPT O.M. No. 35015/2/93-Estt(D) dated 09.08.1995, an offer of appointment should clearly specify the period (which shall not normally exceed one or two months) after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministries/Departments but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum of six months from the date of issue of the original offer of an appointment. An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment. Further, DoPT vide O.M. No. 1259494-Estt.(D) dated 09.08.2017 has advised strict compliance of the instructions of aforesaid O.M. dated 09.08.1995.

In above 22 cases, the centralized offer of appointment was issued to CGLE-2016 passed candidates on 28.02.2018 (the centralized offer of appointment was also forwarded to each candidate separately). As per DOPT instructions, this offer of appointment shall be deemed cancelled automatically on 30.08.2018 in r/o candidates who failed to join the post within stipulated time.

The concerned Pr.CCAs/CCAs/CAs are, therefore, requested to not to grant any extension of joining time further and to ensure that the remaining candidates shall join the post of Accountant well before 30.08.2018 or otherwise the offer of appointment to the candidate shall be deemed as cancelled automatically and no further communication will be entertained in this regard.

The Ministries/Departments shall issue cancellation order in respect of each candidate who failed to join the post upto 30.08.2018, after ensuring completion of all formalities including issue of offer of appointment followed by two reminders separately in each case, under intimation to this office. The reminders shall be issued well before 30.08.2018 specifying the last date of joining as 30.08.2018 in any case. The dossiers of candidates whose offer of appointment cancelled, shall be forwarded to this office upto 14.09.2018 positively alongwith copy of correspondence with candidate and all necessary documents for onward forwarding to SSC.
