Sub: - Training on "CDDO Payment Module" for Key Resource Persons at INGAF, New Delhi.

The "Payment and Accounting Module of PFMS" has been successfully rolled out in 476 PAOs till date. Now, it has been decided to extend the facility of payment including e-payment functionality to CDDOs through PFMS. Till now 417 CDDOs are already onboard and using this functionality.

To further roll-out CDDO Payment Module including e-Payment facility through PFMS a training program on CDDO Module of PFMS is going to be held for the officers and staff of various PAOs **on 18th December, 2018**. The purpose of the training is to familiarize the participants with CDDO functionalities on PFMS, so that the participants can further impart training to their respective CDDOs. It has been decided that all the Pay and Accounts Offices will themselves train CDDOs and implement CDDO module in CDDOs under their purview. Necessary User Manuals and other material will be provided to PAOs by IT Division of CGA which will assist them in imparting training and implementation. The time and venue is mentioned below:-
