
OFFICE MEMORANDUM

Sub.: Combined Seniority List of AAO(C) 2014 (RE) Examination passed officials.

The undersigned is directed to forward herewith a copy of the Combined Seniority List of officials who have passed AAO (C) Re-Exam, 2014. The inter-se-seniority has been fixed in accordance with the following principles:-

1. In respect of directly recruited Accountants, seniority has been reckoned from the date of appointment as Accountant. In case the date of joining is in the afternoon, the seniority has been counted from the next day. Seniority of officials at Sl.No. 2,3,6,12,16,23,24,26,28,39 & 42 has been fixed under this rule.
2. In respect of Accountants who have been promoted from the grade of LDCs, service as LDC upto 6 years has been ignored and the balance service counted as that of Accountant for purpose of fixing of seniority. Officials at Sl.No. 13 and 17 have been assigned seniority under this clause.
3. In the case of LDCs promoted as Accountants after passing the Part I/4 papers of the AAO(C) Exam. and whose date of appointment as Accountant is the same, seniority has been reckoned on the basis of total length of service as LDCs; Seniority of officials at Sl. No. 52, 53 has been fixed under this rule.
4. Service as Stenographer has been equated to service as Accountant if the official is a Graduate. In case the official is non-graduate, the service is equated as LDC (though there is no such official in the present list);
5. From 1.1.96, the DEOs Grade A have been given seniority like Stenographer i.e. graduate DEOs are treated as Accountants and non-graduates as LDCs. Service prior to 1-1-96 is equated at par with LDCs (though there is no such official in the present list).
6. The benefit of 6 years to the LDCs as stated in para 2 above is available for only those LDCs who joined service in CCAS cadre. The benefit has also been given to the officials inducted from BSF/CRPF. The officials transferred from other cadres to CCAS have not been given this benefit.
7. The post of ASI and HC of BSF/CRPF has been treated as equivalent to Accountant and LDC respectively in CCAS cadre. Seniority in respect of Officials at Sl.No.1,4,5,7,9,11,14,15,19,20,21 & 25 has been fixed from the date of appointment as ASI.
8. Seniority in respect of all other officials has been fixed from the date of appointment/absorption as Accountant in CCAS cadre.

The above lists may be circulated amongst all the concerned officials and representations, if any, regarding any discrepancies in the list may be examined in light of the above parameters and sent to this office, latest by 11th May, 2018.
