The 'Integrated Central Civil Accounts Organization' application (Group 'B' Database) is under implementation by this office. The application provides for capturing personal information, employment history and training details and details of APARs. of Group 'B' officers to address the need of effective cadre management.

- 2. Review of progress of furnishing of data by the Ministry/Departments with regard to the above has been made in this organization. The requisite details is being attached vide Annexure 'A'. From the annexure, it has been observed that a large number of AAO/PAO/SrAOs and their respective Principal Accounts Offices have not yet submitted their requisite details in the above database even after repeated reminder from this office.

It is reiterated that the responsibility of initial data entry lies with individual AAOs/AOs/Sr.AO and after the same is furnished by AAO/PAO/SrAO, the verification will be done by the concerned Pr. Accounts Offices of the respective Ministries/Deptt. Thereafter the same should be forwarded to CGA office. The login id will remain same as issued earlier and can be accessed on nic net connection.
- 4. All Pr. CCAs/CCAs/CAs may nominate an official who will ensure furnishing of requisite data under intimation to this office. He/She may be directed to keep in touch with the Group 'B' Section O/o CGA through phone no.2466 5363 or through e-mail groupbsec-cga@gov.in for any issues pertaining to URL address, Login ID/Password. Those AAOs/PAOs/SrAOs who have not yet get themselves registered over the Database application, they may send their details viz.PAN No.,DoB, present post and place of posting at groupbsec-cga@gov.in for registration within the data base application. Thereafter they shall be able to submit their details over the designated URL.

It is, therefore requested that Pr. CCAs/CCAs/CAs may look into the matter personally and ensure the submission of data over the designated URL as mentioned above to this office as per the schedule given below
