OFFICE MEMORANDUM

**Sub: Circulation of list of eligible Multi-Tasking Staff for promotion as Lower Division Clerk on seniority basis (5% Quota) during the vacancy year 2019 -regarding.**

As per Central Civil Accounts Service (Lower Division Clerk, Group 'c' Post) Recruitment Rules 2010, 5% of vacancies shall be filled up on seniority-cum fitness basis from MTS of CCAS Cadre through promotion.
