**ORDER**

In pursuance to Order of DoP&T O.M. No. AB 14017/64/2008-Estt.(RR) dated 24<sup>th</sup> April, 2009, O.M. No. AB 14017/64/2008-Estt.(RR) dated 1<sup>st</sup> July, 2010 and O.M. No. AB. 14017/30/2011-Estt.(RR) dated 14<sup>th</sup> September, 2017, the competent authority has accorded his approval for grant of Non-Functional Upgradation(NFU) to the following four ICAS officers of 1986 batch to Higher Administrative Grade(HAG) pay scale of Level 15 in the Pay Matrix (Pre-revised scale: Rs. 67000-79000/-) with effect from 21.07.2017:-

2. Consequent to this Non-Functional Upgradation, there will be no change in the place of posting of the above mentioned officers and they will continue to remain in their present place of posting.

3. The up-gradation granted under these orders is purely Non-Functional Up-gradation personal to the officers and it does not bestow any right to the officers to claim promotion or deputation benefits based on Non-functional up-gradation in such a manner.

4. Pay fixation on grant of Non-Functional Upgradation under these orders has to be done as per the provisions of CCS(RP) Rules, 2016. In respect of the above officers, he/she will be granted one increment in the Level -14 and he/she shall be placed at a Cell equal to the figure so arrived at in the Level-15 of the post to which he/she is granted Non-Functional Upgradation and if no such Cell is available in the Level-15, he/she shall be placed at the next higher Cell in that Level-15. At the time of regular promotion to this grade, the pay need not be fixed again for the officer who has been granted up-gradation under this order.
