OFFICE MEMORANDUM

Sub: Non-relieving of AAOs/AOs/Sr.AOs under Transfer/Promotion.

Relieving of the AAOs/AOs/Sr.AOs on promotion/ inter Ministry Transfer was one of the issues discussed during CGA's meeting with Pr.CCAs/CCAs/CAs on 20thMarch '18 in the background of this office OM dated 6.3.18 wherein it was intimated that officers under transfer should be relieved by 15th April' 18. After deliberations in the said meeting, CGA agreed to extend this timeline to end of April' 18 in cases where substitutes have been provided.

- 2. Since then, a good number of officials have joined their respective places of postings. But there are also cases where relieving orders may have been issued from Pr.AOs; these are, however, yet to be given effect by the field offices where these officers are working currently. All Pr.CCAs/CCAs/CAs may, therefore, review this position in respect of their respective offices.
- 3. What is a serious issue of concern is that despite CGA's clear directions on 20th March, there are still some Pr.CCAs/CCAs/CAs who are yet to implement the orders. As considerable time has elapsed since the issue of the OM dated 6.3.18 as well as CGA's consent for extending this time to end April '18, there is no justification for not complying with the orders.
- 4. It has, therefore, been decided that AAOs/AOs/Sr.AOs mentioned in the two Lists enclosed will stand relieved from the rolls of the Ministry /Deptts. to join their duties in the allocated Mins/Deptts as per the relevant Orders with effect from the forenoon of 15th May '18, if not already relieved. No formal relieving orders from their present Ministry/Deptt. will be required.
- 5. All concerned AAOs/AOs/Sr.AOs as per the Lists, will ensure that a copy of the joining note submitted at the allocated place of posting is simultaneously endorsed to the undersigned also. It may also be noted that failure to comply with these instructions will make the defaulters liable to punitive action without giving any further notice.
