**ORDER**

On conclusion of disciplinary proceedings, Shri Arun Singhal, Dy. Controller of Accounts (Retd.), ICAS(1996), against whom disciplinary proceedings under Rule 14 of the Central Civil Service Rules, 1965 were initiated vide charge-memorandum dated 22.07.2010 has been exonerated from all charges levelled against him vide order dated 09.12.2016. Consequently, in terms of Para 3 of DoP&T's O.M. dated 14.09.1992, the sealed covers were opened. For the vacancy year 2011-12, the Departmental Promotion Committee (DPC) assessed him as 'Fit'.

2. Consequent upon the approval of the appointing authority, Shri Arun Singhal, ICAS(1996) is promoted notionally to the Junior Administrative Grade(JAG) of Indian Civil Accounts Service (ICAS) in the pay scale of Rs. 15,600 - 39,100 in Pay Band-3 with Grade Pay of Rs. 7,600 (pre-revised) (Revised: Level 12 in the Pay Matrix as per 7<sup>th</sup> CPC) with effect from 08.09.2011 i.e. the date of promotion of his immediate junior Shri Ashish Kumar Singh, ICAS(2002), who was promoted, vide this office order dated 08.09.2011.

3. Shri Arun Singhal shall be entitled for all consequential benefits in terms of Para 3 of O.M. dated 14.09.1992. As he has already been retired from Government Service on 30.06.2012, he is entitled for notional promotion from the date his immediate junior has been given promotion but with all financial benefits as the principle of 'no work no pay' does not apply in this case.

4. In terms of Para 5 of O.M. dated 25.01.2016, Shri Arun Singhal, being a retired Government employee, shall also be entitled to fixation of pension on the basis of such notional pay on his notional promotion.

5. The notional pay fixation for promotion is subject to audit observation.
