OFFICE MEMORANDUM

**Sub: Promotion of LDC as Accountant on the basis of Limited Departmental Competitive Examination under Rule 5(3) of CCAS (Accountant and Senior Accountant Group 'C' posts) Recruitment Rules, 2010 – Reg.**

In terms of Rule 5(3) and Column 11 & 12(5) of schedule of CCAS (Accountant and Sr. Accountant Gr.C posts) RR 2010, 5% of vacancies of the post of Accountant shall be filled up by promotion of LDCs belonging to the service (Level 2) with three years of regular service in the grade and who qualify in the departmental competitive examination conducted by the Controller General of Accounts.

2. The LDCs (30) declared as passed in Limited Departmental Competitive Examination held on 10.01.2018 were considered for promotion as Accountant in order of their rank obtained in Examination, against existing vacancies in the grade under 5% LDCE quota in Central Civil Accounts Service. Out of 30 passed officials, the 13 LDCs have been considered and approved for promotion as Accountant in order of their seniority against the existing vacancies and allocated to the Ministries/Departments on promotion as Accountant as per **allocation list annexed (Annexure-I)**. The remaining 17 LDCs have already been promoted and allocated as Accountant on seniority basis, therefore, not required to be considered for promotion under Examination quota (**list annexed as per Annexure-II**).

3. The promoted Accountants have to pass the Departmental Confirmatory Examination to be conducted by Controller General of Accounts as per terms and conditions specified and on their passing the said test. Further, they shall not be entitled to draw any increment in the Grade until they qualify in the said test and on their passing the said test, their pay shall be re-fixed as if their increments had not been withheld under their proviso, but no arrears of pay shall be allowed for the period the increments had been withheld, in terms of Note 1 below Col. 12(5) of schedule to CCAS (Accountant and Senior Accountant Group 'C' posts) Recruitment Rules, 2010 for the post of Accountant.



4. The appointing authority in the Departmentalized Accounts Organizations may issue promotion order in respect of the LDCs working in their respective offices. While issuing the promotion orders, it may be ensured that the sealed cover procedure is observed as per the instructions issued by DOPT vide OM No. A.22011/4/91-Estt.(A) dated 14-09-1992 as amended from time to time, in the concerned cases.

5. The promotion shall be effective from the date of joining of the official to the promoted post of "Accountant" in all cases.
