OFFICE MEMORANDUM

Subject: Promotion of 12th Class Pass Group 'C' (Multi-Tasking Staff) as LDC on the basis of Limited Departmental Qualifying Examination 2017 under Rule 5(3) of CCAS (Lower Division Clerk Group 'C' post) Recruitment Rules, 2010.

A reference is invited to Rule 5(3) of CCAS (Lower Division Clerk Group 'C' post) Recruitment Rules, 2010 wherein 10% of the vacancies in the grade of LDC are to be filled by promotion on the basis of Limited Departmental Qualifying Examination (LDQE) conducted by Office of the Controller General of Accounts for Multi-Tasking Staff who possess qualification of 12th Pass or equivalent and have rendered three years regular service in the post in Level 1 of 7th CPC Pay Matrix (pre-revised Grade pay of Rs.1800/-).

A combined seniority list of successful Multi-Tasking Staff has been prepared in order of their seniority consequent upon passing the Limited Departmental Qualifying Examination 2017 and approved for promotion as LDC in order of their seniority against the existing vacancies (10% quota) for LDQE in Central Civil Accounts Service. The allocation list is annexed.

The promoted LDCs have to pass the typing test on computer conducted by Staff Selection Commission (SSC). Unless exempted by order issued in this regard by the Controller General of Accounts, a LDC who has not passed the prescribed test will not be entitled to any increments, confirmation or promotion by seniority or through any departmental examination.

This office will not entertain any request for retention or change of transfer/posting orders. Hence, such requests should not be forwarded to this office.

All formalities regarding promotion of MTS to LDC i.e. issue of vigilance clearance/promotion orders/relieving/joining should be completed within seven working days from issue of this OM. Compliance report in this regard should be submitted on or before 10.01.2018 positively to this office for submission to higher authority.
