OFFICE MEMORANDUM

Subject: Review of date of eligibility for promotion as Sr. Accountant of Central Civil Accounts Service (CCAS) Cadre under office of the Controller General of Accounts – reg.

Reference is invited to the representations received in this office on the subject mentioned above and this office's memorandum of even No. 402 dated 17.10.2017 wherein it was stated that benefit of Note below Column 12 of Schedule of Central Civil Accounts Service (Accountant and Senior Accountant Group "C" posts) Recruitment Rules, 2010 will be available to all seniors from the date promotion of his junior in any Ministry having CCAS cadre. It was further mentioned that past cases of promotion from Accountant to Senior Accountant may also be reviewed from the date of issue of notification of CCAS (Accountant and Sr. Accountant) RR 2010 i.e. 01.04.2012.

This office has reviewed the various representations received from employees in this regard with reference to rank and the year of SSC examination. The Pr.CCAs/CCAs/CAs concerned are requested to verify the facts of representations of officials from service book, personal file, SSC dossiers and other relevant documents and ensure that stipulated condition for benefit of Note Below Column 12 of Schedule of CCAS (Accountant and Sr. Accountant) RR 2010 i.e. (i) concerned Accountants are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service (ii) have successfully completed their probation on date of promotion (iii) qualified Departmental Confirmatory Examination on date of promotion and other relevant provisions have been fulfilled by the concerned employees. If cases found fit in all respect, the review DPC may conducted as per provision. Details of such cases may be sent to this office in prescribed proforma (Annexure enclosed) along-with a copy of recommendation of DPC for promotion/antedating promotion.
