Controller General of Accounts has directed that efforts should be made to universalise the coverage of various PFMS modules in the shortest possible time. It has therefore been decided to establish a cohort of 500 Master Trainers in the next few months, who will provide requisite training and hand holding support for each module of PFMS. These trainers will be drawn from amongst the user community to ensure constant updation of knowledge and skills. This will also provide Ministries/ Departments/ State Governments/ Implementing Agencies and SPMUs with required expertise at close quarters.

The proposed course of action necessitates a close involvement of CCAs in various Ministries and Jt. CGAs/SNOs/ ASNOs responsible for various SPMUs so as to ensure delivery of training interventions as per requirements. The personnel identified for a module will be provided intensive training in all functionalities of that module and will then undergo a test leading to their certification as Master Trainers for one or more PFMS modules.

To commence this exercise, the ToT programme for NTRP module has been drawn up. Pr. CCAs/ CCAs are requested to depute the identified officials from 19 Ministries/ Departments, as per enclosed list (Annexure) to INGAF, New Delhi on 25th and 26th May 2018.
