- (i) Registration.
- (ii) Deduction and Deposit of TDS from the payments to be made to provider of Goods and Services and
- (iii) Filing of the monthly Tax Return on the GST portal.

Accordingly, it has been decided to impart one-day training module to train "Master Trainers" for the above requirements in association with GSTN on 30th August, 2018. Participants listed in Annexure-I are hereby directed to attend the training so that they can provide further trainings to DDOs in their jurisdiction / area.
