Sub: Implementation of e-payment system in remaining Pay & Accounts Offices (PAOs) of Civil Ministries/Departments.

The electronic delivery of payment services through Government e-Payment Gateway (GePG) has already been launched in most of the PAOs of Civil Ministries/Departments and it is expected to cover remaining PAOs of Civil Ministries/Departments by 30.06.2013.

- 2. As regards Focal Point Branch for e-payment, it was decided vide OM No.S-11012/ e-payment/7/2012/173-183 dated 27.01.2009 that each bank dealing in Government transactions would identify only one branch as a centralized e-FPB for dealing in e-payment with all Pay and Accounts Offices of the accredited Ministries/Departments and obtain approval of Controller General of Accounts, through Pr.CCA/CCA/CA/Departmental Heads of the concerned Ministry/Department.
- 3. The following e-Focal Point Branches of 4 banks which are accredited banks for the remaining PAOs, had already been authorized vide OM No. mentioned against their names by this office for dealing in e-payment in respect of all Pay & Accounts Offices of various Civil Ministries/Departments related to them who have already commenced e-payment. Accordingly, it has been decided that the following branches of the banks will also act as centralized e-Focal Point Branches for remaining PAOs to which the concerned bank is accredited.

OFFICE MEMORANDUM

Reference is invited to this office OM No. S-11012/e-payment/3/2011/RBD/148 dated 29.02.2012 vide which it was decided as under:-

- (i) All payment transactions taking place through GePG shall now be identified by a prefix "e" added to their running serial numbers in all the statements/reports generated by e-FPB/Link Cells on the bank (GAD, in case of SBI) and CAS, RBI Nagpur.
- (ii) All such e-payment transactions for a particular PAO should be booked by CAS, RBI under a separate PAO Codes preferably be prefixing 'e' to the existing PAO Code.
- 2. RBI has since examined the issue of allotting separate PAO Codes for e-payments (expenditure) and has communicated that it is not possible to create PAO codes by prefixing "e" to the existing PAO Codes on account of technical reasons and has suggested two other options for allotment of PAO Codes for e-payment(expenditure) as explained below.
- 3. RBI shall assign different numeric PAO Codes beween '501' to '999' to all the existing PAOs under Departmentalized Ministries (DM) Account for e-transactions i.e. each PAO will have two PAO codes, one for physical transactions (between 001 to 499) which already exists and another for e-transactions (between 501 to 999) [i.e. additional PAO code for e-payment transactions will be existing PAO code for physical transactions + 500].
- These new PAO codes will be given the same nomenclature as for the existing PAO codes with suffix "e-transactions". With this arrangement, RBI will furnish the details for physical transactions & e-transactions in DMA-1 & DMA-2 separately to facilitate monitoring and reconciliation of e-payment transactions.

5. The revised provisions for additional PAO Codes stipulated in this OM are applicable to all e-payment transactions (expenditure) processed by PAOs through GePG.
