# OFFICE MEMORANDUM

# Subject: e- Payment System: Remittance of Subscription to New Pension Scheme (NPS) through GePG.

NPS subscriptions are not being remitted to Trustee Bank through GePG. The reason indicated is that the requisite details of the Transaction ID and other details could not be furnished in the e-Payment Advice generated through COMPACT and no guidelines have been issued to accredited banks for populating the designated fields in NEFT and RTGS remittance forms with the requisite details.

- 2. The matter has been discussed in the meeting held on 2<sup>nd</sup> November, 2012 with select banks and it has been decided that NPS subscriptions should henceforth be remitted to Trustee Bank through e-Payment using GePG by all PAOs of Central (Civil) Ministries. This would necessitate suitable modification in COMPACT and interface of accredited banks for further processing of e-payment advice to ensure to follow the processes delineated below for remittance of NPS Subscriptions to Trustee Bank:
  - A. PAO Registration No. provided by CRA, Trustee Bank IFSC and Account No. for NPS Payment in Beneficiary Master will be updated in COMPACT by NIC.

#### B. Process at PAO:

- PAO will upload SCF in the CRA System and download the Transaction ID generated by CRA system on successful upload of SCF.
- ii. PAO will then make a bill entry for NPS Bill in COMPACT for amount equivalent to SCF amount uploaded. COMPACT will automatically create e-payment details with IFSC Code and Account No. (from beneficiary Master) and will prompt PAO to enter the Transaction ID generated by CRA for the SCF.
- iii. COMPACT will populate the e-payment details field with NPS<PAO Registration No(7)><CRA Transaction ID(13)>
- iv. PAO will digitally sign and generate the e-payment advice file.

v. PAO will upload e-payment advice to GePG.

## C. Process at Accredited Banks:-

- i. PAO's Accredited Bank will download the e-payment advice file from GePG and for all e-payments being made to Trustee Bank account [IFSC(BKID0000122) + Account No.(012210110002183)], it will follow the following rules as per NSDL Circular No. CRA/ PO&RI/ PAO/ 2012/002 dated 09.04.2012:
- ii. In the case of RTGS mode, Accredited Bank will substitute 'NPS' with 'PAOFIN' and mention PAOFIN<PAO Registration No (7)><CRA Transaction ID (13)> in field 7495 (sender to receive information, line No. 4) of RTGS message. Total no. of characters should be 26 and should not have any space or special characters in between. Further, the fund remittance should be by R-41 RTGS type only.
- iii. In the case of NEFT mode, Accredited Bank will substitute 'NPS' with 'PAOFIN' and mention PAOFIN</br>
  PAOFIN' and mention PAOFIN
  PAO Registration No(7)
  CRA Transaction ID(13)
  in the field 7002 (origination of remittance) of the NEFT message. Total no. of characters should be 26 and should not have any space or special characters in between.
- 3. Accredited Banks are required to automate the above processes and ensure that no human intervention is required for populating the designated fields of RTGS / NEFT with the details of NPS subscription. Accredited Banks should make necessary modification in their interface software to identify NPS Subscription based on unique Key of Trustee Bank Account(IFSC & Account Number) substitution of 'NPS' with 'PAOFIN' in e-payment details and populating designated fields of RTGS and NEFT forms.

You are kindly requested to arrange the remittance of NPS subscriptions accordingly.
