## Office Memorandum

A reference is invited to this office O.M. No.I-115/MF/CGA/ITD/2014-15/02 dated 13<sup>th</sup> August, 2015 regarding enhancement of PFMS for non-plan payments and conveying schedule of sensitization programme for implementation of the system.

- 2. As already informed the enhancement of PFMS for generation of sanctions and bills in respect of all Non-Plan expenditure (except payments in respect of Salary, GPF and Pension) shall be generated and processed for payment through PFMS only with effect from 1st October, 2015. However, pilot run in some Ministries is due to start from 1st September, 2015. The sensitization programme for operational staff in field offices which are participating in the pilot programme from 1st September, 2015 has been conducted on 17th and 18th August 2015. They will also require practical handholding with regard to the various stages involved in the process flow of the system.
- 3. In this regard the following programme for practical training of the operational staff of 24 PAOs (participating in pilot run) across 12 controllers and sensitization programme for DDOs under the payment control of 24 PAOs has been approved by Controller General of Accounts.
