Under article 292 of the Constitution, the Union Government may give guarantees within such limits, if any, as may be fixed by Parliament by law. The statement here shows the position, as on 31st March 2003, of guarantees given by the Union Government for (i) repayment of borrowings and payment of interest thereon, (ii) repayment of share capital and payment of minimum dividend, (iii) payment against agreements for supplies of materials and equipment on credit basis, etc., on behalf of Government companies/corporations, Railways, Union Territories, State Governments, local bodies, joint stock companies, co-operative institutions etc. These guarantees constitute a contingent liability on the Consolidated Fund of India.

In the case of contracts originally entered into with the private railway companies during 1916-1923, the amount guaranteed is limited to the amount required to make up the net return of these companies 3 per cent to 3-1/2 per cent / 5 per cent per annum on their paid-up share capital amounting to Rs. 196.65 lakhs. Share capital also includes the amount in respect of Chaparmukh-Silghat Railway Co. Ltd., Rs. 2.63 lakhs, Katakh-Lalabazar Railway Co. Ltd., Rs. 6.50 lakhs and Futwah Islampur Light Railway Co., Rs. 11.50 lakhs which have been nationalised w.e.f 17-8-82, 17-8-82 and 30-12-85 respectively, hence no guarantees are outstanding.

A total amount of Rs. 0.60 lakh was paid in the case of Ahmedpur-Katwa Railway Company Ltd., on Eastern Railway during 2002-2003 in pursuance of the guarantees. A sum of Rs. 21,83,196 to the end of March 2003 representing the net earnings of Central Provinces Railway Company Ltd., Mumbai worked by Indian Railways has also been paid.
