of Accounts.

Sir,

In exercise of the powers conferred on this Ministry
vide item (2) of Annexure I to this Ministry's O.M.No.F-
10(13)-E(Coord)/75, dated the 10th April, 1975 read with
O.M. dated the 8th March, 1976, the undersigned is directed
to say that the President is pleased to decide that the
Controller General of Accounts will exercise all powers
vested in a Ministry/Department of the Government of India
under the rules mentioned below in respect of affairs of
his Organisation:-

- (i) Delegation of Financial Powers Rules, 1958.
- (ii) General Financial Rules, 1963.
- (iii) Fundamental Rules & Supplementary Rules.

2. The powers in respect of the following items shall
not be exercised by the Controller General of Accounts:-

- (i) Creation of Posts.
- (ii) Write off of losses.
- (iii) Appropriation and Re-appropriation of budget
provision.

3. The powers delegated to the Controller General of
Accounts will be exercised by him in consultation with
the I.F.A. to the Ministry of Finance, Department of
Expenditure.



4. The exercise of the delegated powers will be subject to the conditions laid down in Rule 10(5) of the D.F.P. Rules, 1958 and subject to other procedural and economy instructions etc. issued by Government from time to time.

 - (a) All financial sanctions issued by him in exercise of the powers delegated to him should denote the exercise of the delegated powers and not involve the name of the President. A copy of the sanction issued should invariably be endorsed to Integrated F.A. and A&B Branch.
 - (b) Since devolution of financial powers along with responsibilities is an integral part of the scheme of delegation of financial powers, the powers now delegated should in turn be redelegated to subordinate authorities/lower formations.
