OFFICE MEMORANDUM

Subject: Releasing of payments through CompDDO software for Implementation of Bhavishya software- regarding

In order to ensure timely payment of retirement dues to the retiring employees and to track the pension payment and subsequent retirement dues, 'Bhavishya webportal' has been developed by Department of Pension & PW.

2. The portal runs on the data relating to retiring employees uploaded in CompDDO software by the DDOs. An interface has also been developed by NIC to facilitate uploading of an xml file generated from CompDDO having details of data into the Webportal.

3. JS, PPG&P vide DO Letter No. 55/4/2014-P&PW(C) dated 14th October, 2014 (copy enclosed) has emphasized on ensuring the consistency of uploading the accurate requisite data including the PAN number, Date of Birth, Mobile Number and e-mail id of the employees to the software by the concerned DDOs.

4. CompDDO being a comprehensive software package to cater to all the practical requirements of DDOs and also the launching vehicle for software utilities like Bhavishya and eSamarth etc., it is imperative for all DDOs to switch over from either manual procedures or standalone packages to this integrated generic and comprehensive software utility immediately.

5. In order to streamline the process of uploading data of CompDDO into Bhavishya webportal, all the Pr.CCAs/CCAs/CAs(with independent charges) are requested to emphasize its implementation in all the DDOs especially merged DDOs under their ministry. Necessary instructions in this regard may be issued to all their PAOs so as to ensure uploading of data by DDOs under them regularly to the software.

As you are aware your Ministry/Department is implementing a web based project called online Pension Sanction and Payment Tracking System "Bhavishya" to ensure that the retiring government servant gets his retirement dues on time. "Bhavishya" is being implemented in three phases. Phase-I & Phase-II of the Bhavishya application has been initiated in 20 Ministries/Departments. Phase-III i.e. link with PAO, CPAO & Banks etc. is in process of completion and will be introduced shortly.

2. To ensure retirement dues are paid on time, it is imperative that the time lines indicated in the CCS (Pension) Rules, 1972 for completion of various stages of Pension sanction and payment procedure are adhered to and the progress is monitored closely. The Bhavishya software is linked with the salary package Comp DDO and information is automatically being picked up. Therefore, it is important that the data, including the PAN number, date of birth, mobile number and e-mail id (wherever possible), relating to the retiring employees is appropriately populated in the Comp DDO package. The concerned HOO/DDO must also be sure of the accuracy of this data. It is likewise important that COMP DDO data is being uploaded every month by DDOs immediately after the salary is processed.

3. Please issue necessary instructions to the concerned officers of your Ministry/Department for successful implementation of the Bhavishya application which will in turn ensure streamlining of the sanction and payment of retirement dues.
