ORDER

In pursuance to the order of DOP&T OM No. AB 14017/64/2008-Estt.(RR) dated 24th April, 2009, OM No. AB 14017/64/2008-Estt.(RR) dated 1st July, 2010 and OM No. AB. 14017/30/2011-Estt.(RR) dated 26th April, 2016, approval of the competent authority is accorded for grant of Non-Functional up-gradation in respect of Shri Siddharth Sharma, ICAS(1996) in the Senior Administrative Grade in the Pay Band of Rs.37400-67000 (PB-4) with Grade Pay Rs.10,000 with effect from 17th March, 2016 and will be regulated as under:

i) During tenure on Deputation under Central Staffing Scheme

The pay from 17th March, 2016 to 7th June, 2016 will be regulated by grant of one increment at the rate of 3% of basic pay on account of the non-functional upgradation, but his grade pay will remain unchanged on the ground that he was holding a particular post with a specific grade pay under the Central Staffing Scheme. In this case the officer granted non-functional upgradation may continue to draw CDTA, if admissible.

ii) <u>During present posting as Internal Financial Adviser on co-terminus basis with the Hon'ble President, President's Secretariat, on Deputation under non Central Staffing Scheme</u>

The pay fixation from 08.06.2016 onwards will be regulated by invoking the provisions of CCS(RP) Rules, 2008 i.e. the difference of grade pay will be added to their basic pay. At the time of regular promotion to this grade, the pay need not be fixed again for the officers who have been granted up-gradation under these orders.

2. The up-gradation granted under these orders are purely Non-Functional up-gradation personal to the officer and it does not bestow any right to the officer to claim promotion or deputation benefits based on Non-functional up-gradation in such a manner.
