Subject:- Appointment of successful candidates of Combined Graduate Level Examination (CGLE), 2023 - Court matters arising out of W.P. (C) No. 16593/2023 filed by Shubham Pal & Ors. - reg.

Please refer to CGA's O.M. No. NGE-12001/1/2023-NGE-CGA/63 dated 29.04.2024 on the subject cited above wherein it was requested to incorporate a clause in the Offer of Appointment to be issued to the nominated candidates of CGLE-2023 that "the appointment would be subject to the outcome of LPA No. 202/2024 filed by Shubham Pal & Ors. against the verdict pronounced in the Writ Petition (C) No. 16593/2023 by the Single Bench of the Hon'ble High Court of Delhi".

- 2. In this connection, it is informed that the said Writ Petition (C) No. 16593/2023 and LPA No. 202/2024 filed by Shubham Pal & Ors. have been disposed of. Furthermore, LPA No. 319/2024 filed by SSC before the Division Bench of High Court of Delhi has also been disposed of, granting liberty to SSC to take appropriate steps before the Ld. Single Judge as per Law. Accordingly, the Commission is in process of filing a Review Petition before the Ld. Single Bench of the High Court of the Delhi.
- 3. Therefore, the User Departments in the Ministries/Departments (Civil), being the Appointing Authorities, are requested to comply the following as per directions of the SSC: -
- (i) not to issue any fresh appointment letters related to the SSC CGLE-2023 examination, and
- (ii) the appointment letters already issued shall continue to be subject to the conditions stipulated in SSC's previous letters, duly communicated to User Departments for compliance vide CGA's OMs No. NGE-12001/1/2023-NGE-CGA/1016 dated 01.01.2024 and No. NGE-12001/1/2023-NGE-CGA/63 dated 29.04.2024.
