OFFICE MEMORANDUM

Subject: Onboarding of Schemes from CSNA Module to TSA/Hybrid TSA under Centrally Sponsored Schemes (CSS) — Reg

The undersigned is directed to refer to this Department's O.M. No. 1(13)/PFMS/2021 dated **24.05.2023** and subsequent O.M. dated **06.06.2025**, regarding the implementation of the **Central SNA (CSNA)** module for release of funds directly to Implementing Agencies under CSS. It has been decided that, with effect from **01.08.2025**, the CSNA facility shall operate under the **Treasury Single Account (TSA)/ Hybrid TSA** model, replacing the existing commercial bank-based mechanism.

2. As per the transition plan communicated vide O.M. dated 06.06.2025:

- In cases where the CSNA and all downstream agencies are Government entities and the implementation hierarchy does not exceed two levels, the **TSA model** (using RBI accounts) shall be followed.
- In all other cases, the **Hybrid TSA model** shall be adopted, wherein the CSNA agency will open a TSA account in RBI to fund the commercial bank accounts of the lower-tier implementing agencies.

3. A list of CSS schemes currently onboarded under the CSNA module and identified for transition to **TSA/Hybrid TSA** is enclosed as *Annexure-I*. Ministries/Departments administering these schemes are requested to:

- Review and finalize the applicable operational model (TSA/Hybrid TSA) for each scheme.
- Ensure that the CSNA agency is registered in PFMS and the TSA account is opened in e-Kuber with RBI.
- Facilitate mapping of the CSNA/TSA agency and associated scheme components on PFMS.
- Coordinate with respective Program Divisions and TSA team, PFMS to ensure timely onboarding and system configuration.
