I am directed to refer your e mail dated 2<sup>nd</sup> July, 2024, and to state that there are provisions available in the existing RRs for taking lower grades officers to the post of Sr. AO, AAO, Accountant and the same has already been provided to CGA vide DO letter dated 19<sup>th</sup> June, 2024 (copy enclosed for ready reference).


2. In this regard, it is to inform that as per existing Recruitment Rules to the post of Sr. Accounts Officer NHRC (Level-9) - Officers holding analogous posts in the Accounts Organizations or Officers in the scale of ₹ 2375-75-3200-EB-100-3500 (Pre-revised) (now corresponding to Level 8 of pay matrix) working in the Accounts Organization with 2 years regular service in the grade is eligible for deputation. Further, if any Sr. AO, AAO, Accountant and Junior Accountant of your organization drawing higher pay scales than the pay scale being admissible in the NHRC is willing to work in the same post in the Commission, their pay will be protected by the Commission.

3. It is also to inform that all employees of the NHRC, including those on deputation, are eligible for allotment, extension, and retention of General Pool Residential Accommodation (GPRA) in Delhi/ NCR as per the norms and are also covered under CGHS.

4. It is therefore, requested to sponsor nomination of willing and eligible officers/ officials for these posts to enable the Commission to fill up these vacancies at the earliest.
