Office Memorandum

This is with reference to the meeting held on 25.06.2025 under the chairmanship of the CGA regarding the submission of Appropriation Accounts Stage-II (Manual) and Stage-I (on PFMS). The CGA has viewed the delays very seriously.

2. Reference is also invited to this office O.M dated 22-04-2025 wherein instruction regarding parallel run of SCT module through online submission on PFMS were issued. In this regard, it is observed that some Ministry/Department (listed in Annexure A) have not yet submitted their online SCT on PFMS and in addition to this few Ministry/Department (listed in Annexure B) have also not furnished the hard copies of submitted SCT to the O/o CGA.
3. Timely acceptance of SCT on PFMS is a requirement for availability of Stage-II Appropriation Account on PFMS.
4. Given the tight timeline, it is requested that all Ministries/Departments should ensure about timely submission of SCT on PFMS along with furnishing of hardcopy of submitted SCT by **03 July 2025 (Thursday)**.
