ORDER

In pursuance to Order of DoP&T O.M. No. AB 14017/64/2008-Estt.(RR) dated 24th April, 2009, O.M. No. AB 14017/64/2008-Estt.(RR) dated 1st July, 2010 and O.M. 2. Consequent to this Non-Functional Upgradation, there will be no change in the place of posting of the above-mentioned officers and they will continue to remain in their present place of posting.
3. The upgradation granted under these orders is purely Non-Functional and personal to the officer. It does not bestow any right to the officer to claim promotion or deputation benefits.
4. Pay fixation on grant of Non-Functional Upgradation under these orders has to be done as per the provisions of CCS(RP) Rules, 2016. In respect of the above officer, she will be granted one increment in Level -14 and she shall be placed at a Cell equal to the figure so arrived at in Level-15 of the post to which she is granted Non-Functional Upgradation and if no such Cell is available in Level-15, she shall be placed at the next higher Cell in Level-15. **At the time of regular promotion to this grade, the pay need not be fixed again for the officer who has been granted up-gradation under this order.**
