Subject:- Promotion of Accountant to the post of Senior Accountant on seniority-cum-fitness basis for the Vacancy Year 2027 - regarding.

The undersigned is directed to refer to this office's O.M. No. 54/26 dated 14.05.2026 on the subject cited above wherein the Departmentalized Accounts Organization (DAOs) functioning in Ministries/Departments (Civil) were requested to prepare a select list of Accountants eligible as **on the crucial date of eligibility i.e. 01.01.2027** in terms of DoPT O.M. No. 22011/4/2013/Estt(D) dated 08.05.2017, for consideration of their promotion as Senior Accountant under 50% seniority quota for the vacancy year 2027 and the eligibility conditions mentioned in columns No. 10 and note (1) below column No. 11 of the Schedule to the Central Civil Accounts Service (Senior Accountant Group 'B' Non-Gazetted post) Recruitment Rules, 2025.

2. In this regard, the DPC meetings in respect of concerned Ministries/Departments (Civil) were held and the select lists of eligible Accountants alongwith the Departmental Gradation List of Accountants in each Ministry/Department and a copy of DPC minutes in respect of those Accountants who have been found FIT for promotion as Senior Accountant on seniority-cum-fitness basis under 50% seniority quota for the vacancy year 2027, received in this office for approval of the Competent Authority.

3. Accordingly, the approval of the Competent Authority in Office of the Controller General of Accounts of India is hereby conveyed for promotion of a total of 342 Accountants as Senior Accountant on seniority-cum-fitness basis against vacancies under 50% seniority quota for the vacancy year 2027, as per list-I and list-II enclosed herewith.

4. The LDCs promoted as Accountant on the basis of passing four papers of AAO (Civil) Examination-2014 (later cancelled) shall not be considered for promotion as Sr. Accountant until further instructions as the matter is sub-judice.

5. The Appointing Authority in the Departmentalized Accounts Organizations may, therefore, issue promotion order in respect of Accountants working in their respective organizations who have been approved for promotion as Senior Accountant as per List mentioned in Para 3 above. While issuing promotion order, it may be ensured in the cases, wherever required, that the sealed cover procedure is observed as per the instructions issued by the DOPT vide O.M. No. A.22011/4/91-Estt.(A) dated 14-09-1992 as amended from time to time.

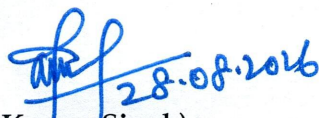
6. The appointing authorities in the Ministries/Departments before issuing promotion order, may ensure the following:-

- 6.1 the official fulfils all eligibility conditions as mentioned in Recruitment Rules of the post of Senior Accountant including clearance of the probation period and correctness of particulars of the official(s) being promoted, as provided to DPC and O/o CGA in the select list viz. date of joining as Accountant, SSC CGLE Batch, Rank number, clearance of probation period and passing of the Departmental Confirmatory Examination, etc. and in case of any discrepancy, it may be brought to the notice of this office immediately before issuance of the promotion order.
- 6.2 the promoted officials will be placed under two years' probation in terms of Col. (9) of the schedule to RRs of the post of Senior Accountant.
- 6.3 that official is not undergoing any penalty under CCS (CCA) Rules, 1965; and
- 6.4 the disciplinary proceedings are not pending or being contemplated against the official.

7. The date of promotion of (i) 313 Accountants (as per List-I) as Senior Accountant shall be from their date of taking over charge as Senior Accountant on or after 01.01.2027 and (ii) the date of promotion of 29 Accountants (as per List-II), approved for promotion as Senior Accountant under junior clause, shall be from the date of joining of their respective junior as Senior Accountant or their date of joining as Senior Accountant, whichever is later, subject to provisions of F.R. 17(1). A copy of joining order shall be forwarded to this office invariably.

This issues with approval of the Competent Authority.

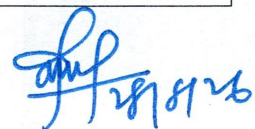
