OFFICE MEMORANDUM

Subject: Combined Seniority List of Sr. Accountants for promotion as AAO under 10% Seniority Quota basis for the year 2026.

Reference is invited to the **Combined Seniority List (CSL) of Sr. Accountants (Sr. Acctt.)** uploaded on CGA's website vide Office Memorandum (O.M.) dated 13.03.2026, for information of all concerned. The Ministries/Departments were requested to verify the details of all eligible Sr. Acctts and point out any discrepancies so that this office could take further necessary action for promotion of Sr. Acctts as Assistant Accounts Officers (AAO) under 10% Seniority Quota.

2. In response to above cited O.M., many Ministries/Departments intimated discrepancies for correction in the CSL. After carrying out all the corrections intimated by Ministries/Departments, a finalized seniority list of Sr. Acctts was uploaded on CGA's website vide OM dated 26.05.2026.

3. It has now been noticed that in-spite of finalizing the list once, requests for inclusion of names of Sr. Acctts were being repeatedly received in this section from various Ministries/Departments for inclusion in the CSL.

4. Therefore, in order to expedite the finalization of the CSL and to take further action for promotion of Sr. Acctts as AAOs under 10% quota, this office had also requested all the Ministries to furnish a certificate stating that **"the details of all eligible Sr Accountants under the Ministry/Department have been forwarded to this office after due verification and no name of any Sr Accountant has been left out"**. The

certificate was to be provided latest by 16.06.2026. However, the requisite certificate has not been received from all the Ministries/Departments, which is delaying the work related to the promotion of Sr. Acctts as AAO under the 10% promotion quota.

5. In view of the above, all the Pr. CCAs/ CCAs/ CAs are again requested to furnish the certificate stating that **"the details of all eligible Sr. Acctts under the Ministry/Department have been forwarded to this office after due verification and no name of any Sr. Acctt has been left out"**, latest by 10th July, 2026 failing which the CSL issued on 26.05.2026 (incorporating all subsequent corrections pointed out) will be treated as final and further necessary action for promotion of Sr. Acctts as AAOs under 10% quota will be initiated accordingly.

This issues with the approval of the Competent Authority.
