OFFICE ORDER

Subject: Submission of options for transfer/posting of AAO (C) CBT 2022 Batch - reg.

Reference is invited to Para 4.4 of the Transfer Policy dated 12.02.2024, which stipulates that "In case an officer is retained on promotion at the same station, the officer is liable to be transferred outstation under rotational transfer on completion of the tenure."

2. This office is in receipt of transfer requests from AAOs who have completed their prescribed tenure and exercised their options for posting to stations of their choice. It is further submitted that no eligible candidates are presently available for posting as substitutes against the transfer of the aforesaid AAOs.
3. In this connection, it is stated that a majority of the AAOs of CBT 2022 Batch were posted at their existing stations on promotion as AAO against the vacancies available at the time of their posting in relaxation to the para (xvi) of the then Transfer Policy dated 30.10.2015. Hence, in order to ensure the consideration of transfer requests of AAOs who were earlier posted at outstation on promotion, it is proposed to transfer the AAOs of CBT 2022 Batch who were promoted at their existing stations and have completed the prescribed tenure at their respective stations under the provisions of para 4.4 of the Transfer Policy dated 12.02.2024.
4. The updated vacancy position of AAOs is enclosed as **Annexure 'A'**.
5. Accordingly, AAOs (C) of CBT 2022 Batch who were promoted at their existing stations and have completed the prescribed tenure at their respective stations as on 03.07.2026 may exercise their options for posting against the vacancies indicated in **Annexure 'A'** latest by 24.08.2026.
6. The final transfer/posting of the AAOs in the IMT shall be considered as per the extant transfer policy, subject to **seniority, availability of vacancies, and administrative requirements.**
