

2. In this connection, it is stated that the SSC has informed that the matter has attained finality following the Hon'ble Supreme Court's judgment delivered on 03.02.2026. The appeal preferred by the Staff Selection Commission (SLP No.1590-1591/2025) has been allowed, while the appeals preferred by Shubham Pal & Ors, (SLP No. 21999/2024) and Rakshit Kumar & Ors. (SLP No. 22002/2024) have been dismissed.
