OFFICE ORDER

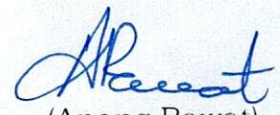
Subject:- Declaration of Joint Controller General of Accounts, O/o the CGA as Appointing and Disciplinary Authority and to act as Chairperson of DPC in respect of all Group 'B' posts where there is no Chief Controller of Accounts in DAOs, Ministries/Departments (Civil) - reg.

Attention is invited to the following provisions contained in Central Civil Services (Classification, Control and Appeal) Rules, 1965 and extant Recruitment Rules of Group 'B' posts of Central Civil Accounts Service: -

- (i) As per Sl. No. 33 of Part-II – CCS, Group 'B' of Schedule to the CCS (CCA) Rules, 1965 provides that the Chief Controller of Accounts in a Ministry or Department or Jt. Controller General of Accounts, O/o the CGA where there is no Chief Controller of Accounts in Ministry/Department, is declared as the Appointing/Disciplinary Authority in r/o of all Group 'B' posts of Departmentalized Accounts Offices in Ministries/Departments (Civil).
- (ii) Further as per relevant CCAS, AAO (Gr - B Post) Recruitment Rules - 2025, the Chairperson of the Departmental Promotion or Confirmation Committee (Group 'B') is the Chief Controller of Accounts in Ministry/Department OR the Jt. Controller General of Accounts, O/o CGA where there is no Chief Controller of Accounts in the Ministry/Department, where Departmental Promotion or Confirmation Committee takes place.

In this regard, the Competent Authority has decided to nominate **Sh. Rokhum Lalremruata, ICAS working as Jt.CGA (HR 1 & 2), O/o CGA to act as Appointing and Disciplinary Authority and Chairperson of DPC** in such cases where there is no Chief Controller of Accounts in the Ministry/Departemnt (Civil), with immediate effect and until further orders.

This issues with approval of the Competent Authority.
