Subject:-Promotion of Multi-tasking Staff to the post of Lower Division Clerk on seniority-cum-fitness basis (5% quota) for the Vacancy Year 2026 - regarding.

I am directed to invite reference to the provisions contained in Rule 5(2) of the Central Civil Accounts Service (Lower Division Clerk Group 'C' post) Recruitment Rules, 2010 for promotion of Multi-tasking Staff to the post of Lower Division Clerk on seniority-cum-fitness basis for the vacancy year 2026.

- 2. Vide this office's O.M. No. 237/25 dated 01.08.2025, the Ministries/Departments were requested to furnish information regarding (i) vacancy position in the post of Lower Division Clerk under seniority quota (5% quota) for the vacancy year 2026; and (ii) certified copy of the Departmental Gradation List of Multi-tasking Staff i.e. feeder grade post, prepared and maintained by the respective Ministry/Department.
- 3. In this regard, a list of MTS is attached vide Annexure-A containing names of MTS in order of their combined seniority prepared for the sole purpose of governing promotion of MTS as LDC on seniority-cum-basis under 5% quota as per Rule 5 of the extant CCAS Recruitment Rules, 2010 of the post of LDC and on the basis of information provided by the Ministries/Departments for the vacancy year 2026.
- 4. The concerned Ministries/Departments are requested to hold a meeting of the DPC in respect of (i) MTS whose names are mentioned in the list attached at Annexure-A; and (ii) their seniors, if any, who are found eligible but not mentioned in the list referred above. The name of eligible MTS recommended for promotion as LDC on seniority-cum-fitness basis shall be considered for approval subject to (a) fulfilling eligibility conditions provided in the extant Recruitment Rules, 2010 of post of LDC as on 01.01.2026 i.e. the crucial date of eligibility as per DoP&T O.M. No. 22011/4/2013-Estt(D) dated 8th May, 2017; and (b) availability of sufficient vacancies of LDC under seniority quota (5%) for the vacancy year 2026 as reported by the Ministries/Departments.

- 5. The officials mentioned in List at Annexure 'A' who were if found 'unfit' or deferred on previous occasion, may also be considered afresh by the DPC for the vacancy year 2026. The cases, if any, in which the promotion was not accepted by the official and consequently debarred for promotion for one year, the DPC may consider such cases afresh for the vacancy year 2026 on completion of debarment period in terms of DoP&T OM No. 22011/18/87-Estt (D) dated 09/04/1996, wherever applicable.
- 6. The name of eligible officials may be considered and placed in the select list (in prescribed proforma at Annexure 'B') in order of their inter-se-seniority in the Gradation List prepared and maintained by the respective Departmentalized Accounting Office, for forwarding to this office.
- 7. The following information may, therefore, be forwarded to this office: -
 - 7.1 "Select List" of eligible officials mentioned in the List attached at Annexure 'A', who were considered and found 'FIT' and recommended by respective DPC for promotion as LDC on seniority-cum-fitness basis (under 5% quota) or declared 'UNFIT'/'DEFERRED', containing details of officials in prescribed proforma enclosed herewith at Annexure-'B', duly attested by the Sr.AO/ACA/Dy.CA/CA/CCA; and
 - 7.2 Copy of minutes of DPC.

The above requisite information shall reach to this office by 28th November, 2025 positively.
