Subject: - Promotion of Lower Division Clerk to the post of Accountant on seniority-cum-fitness basis (25% quota) for the Vacancy Year 2026 - regarding.

I am directed to refer to the terms of Rule 5(2) of relevant Central Civil Accounts Service (Accountant Group 'C' posts) Recruitment Rules, 2021, the vacancies under 25% seniority quota in the grade of Accountant (Pay Level 5) for the vacancy year 2026 are to be filled from LDCs of Central Civil Accounts Service with not less than 5 years' service.

- 2. In this regard, this office vide CGA's O.M. of even No. (403) dated 01.10.2025 had requested Ministries/Departments to furnish information regarding vacancy position of Accountants under seniority quota (25% quota) for the vacancy year 2026 and a copy of Departmental Gradation List of Lower Division Clerk i.e. feeder grade post, prepared and maintained by the respective Ministry/Department.
- 3. On the basis of information received from Ministries/Departments in response of this office's aforesaid O.M. dated 01.10.2025, a list of LDCs is attached vide Annexure—A containing names of LDCs in order of their seniority in the combined seniority list prepared in this office for the sole purpose of governing promotion of LDC as Accountant on seniority basis as per Rule 5(2) of recruitment rules of the post of Accountant, who are covered under zone of consideration for promotion to the post of Accountant for the vacancy year 2026.
- 4. It is, therefore, requested to hold a meeting of the Departmental Promotion Committee (DPC) by the respective Offices in Ministries/Departments in respect of concerned officials as mentioned in list at Annexure-A, and their seniors in case name is not included in the list at Annexure-A, if any, subject to (i) their fulfilling eligibility conditions as per the Recruitment Rules of the post of Accountant, as on 01.01.2026, i.e. the crucial date of eligibility as per DoP&T O.M. No. 22011/4/2013-Estt(D) dated 8th May, 2017 and (ii) availability of vacancies for the vacancy year 2026 as reported by Ministries/Departments. The officials mentioned in the List at Annexure 'A' who were if found 'unfit' or deferred on previous occasion, may also be considered afresh by the DPC for the vacancy year 2026. The cases, if any, in which the promotion was not accepted by the official and consequently debarred for promotion for one year, the DPC may consider such cases afresh for the vacancy year 2026 on completion of debarment period in terms of DoP&T OM No. 22011/18/87-Estt (D) dated 09.04.1996, wherever applicable.

- 5. The names of the eligible officials may be considered by the respective DPCs in Ministries/Departments and placed in the select list in order of their inter-se-seniority in the Departmental Gradation List maintained by the respective Departmentalized Accounting Office. The same may be forwarded to this office for further necessary action.
- 6. In summary, the following information is to be forwarded to this office: -
- 6.1 A "Select List" of officials mentioned in List at Annexure 'A', who were considered and found 'FIT' and recommended by respective DPC for promotion as Accountant on seniority-cum-fitness basis (under 25% quota) or declared 'UNFIT'/'DEFERRED', containing details of officials in prescribed proforma enclosed herewith at Annexure-'B', duly attested by the Sr.AO/ACA/Dy.CA/CCA; and
 - 6.2 A copy of DPC minutes.

The above requisite information shall be furnished to this office on most immediate basis but not later than 16.12.2025 in any case.
