OFFICE MEMORANDUM

Subject:- Extending of reservation in promotion of PwBD employees-reg.

I am directed to invite reference to this office O.M. No. A-65061(55)/17 6/2025/Misc./M.F.CGA (A)/HR-III/779 dated 12.03.2025 (copy enclosed) vide which Senior Accounts Officers (Sr. AOs), working in the Controller General of Accounts of India (CGA) organisation, with Benchmark Disabilities (PwBD) were requested to register themselves on the UDID portal of the Department for Empowerment of Persons with Disabilities, M/o Social Justice and Empowerment. They were also directed to submit Disability Certificates/Unique Disability IDs duly verified by an officer not below the rank of Dy.CA to this office. It has been observed that the requisite UDID disability Certificates have still not been received from some of the concerned Sr.AOs.

2. Further, as per Para 5(i) of the DoPT O.M. dated 28.12.2023, extension of benefits of promotion to PwBD employees to the grade of PAO on notional basis w.e.f 30.06.2016 (till the PwBD employees actually assumes the charge of the post) will only be extended in respect of the following Sr.AOs after holding Review DPC.

4. Further, four of the above-mentioned officers who have not provided their UDID Disability certificates may be requested to provide the same on an urgent basis.
