
2. The appointment on promotion shall be governed by the CCAS (Sr. Private Secretary) Recruitment Rules, 2024 and other rules and orders issued from time to time by the Government of India and the Controller General of Accounts of India as are applicable to the post of Sr. Private Secretary.

3. The O/o Pr. CCA, CBDT may issue order for promotion of the above official as Senior Private Secretary after satisfying that none of the circumstances for adoption of sealed cover procedure as laid down in the DoP&T OM No. 22011/4/91/Estdt.(A) dated 14.09.1992 or in any subsequent instructions of the Government of India exist and ensuring that the official is not undergoing any penalty under CCS (CCA) Rules, 1965 incorporating the terms and conditions in Para 2 above with a copy to this office.

4. The Departmentalized Accounts Office issuing promotion order may also inform the above official that he can be debarred of promotion as per DoP&T orders if declines to accept promotion and thereby loose inter-se-seniority.

5. Refusal by individual to accept promotion will be subject to acceptance by this office.

6. The date of taking over as Sr. Private Secretary by the official may be intimated to this office.
