**Subject:- Promotion of Lower Division Clerk to the post of Accountant on seniority-cum-fitness basis (25% quota) for the Vacancy Year 2026 – regarding.**

Reference is invited to O/o CGA's O.M. No. 301/25, issued under reference No. NGE-11004/1/2025-NGE-CGA/598 dated 30.12.2025, wherein LDCs of CCAS Cadre were promoted to the post of Accountant, on seniority-cum-fitness basis (25% quota) for the Vacancy Year 2026.

2. In this connection, O/o the CGA of India has received a number of representations from these LDCs, received through their respective Principal Accounts Office in Ministries/Departments, with respect to forgo / re-allocation of promotion to the post of Accountant on seniority-cum-fitness basis (25% quota), offered to them vide aforesaid O.M. dated 30.12.2025.

3. The willingness to forgo promotion / refusal to accept promotion to the post of Accountant, by the respective LDCs has been duly considered and accepted by the Competent Authority in this office from the date of their forgo request, as per the details mentioned at **Annexure-I** of this OM. Further, in terms of Para 17.12 of DOPT OM No. 22011/5/86-Estt.(D) dated 10th April, 1989, the officials shall be debarred for promotion for one year w.e.f. the date of their request to forgo the promotion as Accountant.

4. The concerned officials may be informed that they will not be issued any fresh offer of appointment for promotion for a period of one year from the date of their refusal to accept promotion. Further on eventual promotion, they will lose seniority vis-à-vis their junior promoted as Accountant earlier. Also, the debarment would not confer any right to individual for posting at the choice station/office after the lapse of debarment period.

5. Further, the Competent Authority has approved the re-allocation of the officials, as per the details mentioned at **Annexure-II** of this O.M.

6. The terms and condition stipulated in the O.M. No. 301/25 dated 30.12.2025 will remain unchanged and shall be applicable for re-allocated LDCs.


