Sub.: Mandatory Training (Online) for AAOs under Consideration Zone for Promotion as SrAO -reg.

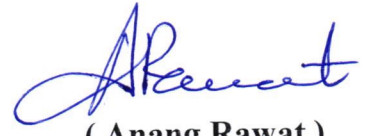
