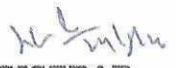
Recruitment Rules for the post of Assistant Internal Audit Officer is as under:

OR
in the pay scale of Pay Level 07/Pay Level 08 having minimum 3 years of experience in Pay Level 07/Pay Level 08.
