2. In this connection, the requisite information/Certificate is yet to be received from Ministries mentioned below as per Annexure A & Annexure B enclosed.

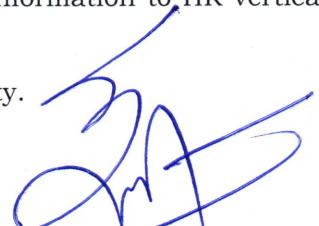
