1. AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provi der must be located in the state of Consignee. For the purpose of Documentary Evidence, the bidder is required to submit the GST registration certificate only wherein the address of the registration shall be indicated as Delhi. Other certific

ates shall not be acceptable for the purpose of availability of office of service provider.

- 2. Bidder financial standing: The bidder should not be under liquidation, court re ceivership or similar proceedings, should not be bankrupt. Bidder to upload und ertaking on Rs. 10/- non-judicial stamp paper to this effect with bid. The bid nu mber should be clearly mentioned in the said undertaking, failing which the bid shall be rejected. The stamp paper shall also be verified for genuinity during the evaluation process. In case, it is found that the uploaded undertaking is not on the genuine non-judicial stamp paper, the bid shall be rejected.
- 3. Bidder's offer is liable to be rejected if they don't upload any of the certificate s / documents sought in the Bid document, ATC and Corrigendum if any.
- 4. Dedicated /toll Free Telephone No. for Service Support: BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.
- 5. Escalation Matrix For Service Support: Bidder/OEM must provide Escalation M atrix of Telephone Numbers for Service Support.
- 6. Duration of the service contract may be extended up to 6 months beyond the initial contract duration (subject to satisfactory performance and mutual consent).
- 7. The bidder shall be required to submit the proof of their contribution to the La bour Welfare Fund in line with the provisions imbibed under "The Delhi Labour Welfare Fund Rules, 1997". This may be verified during the evaluation of the bid.
- 8. PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salar ies / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.
- 9. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placeme nt of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly
- 10. A monthly performance certificate in respect of the resources deployed, shall be obtained from the respective verticals or officers of the PFMS to whom these resources are attached. In the event that the performance of any resource is deemed unsatisfactory by the PFMS based on the evaluation, PFMS reserves the right to instruct the Vendor to replace such resource(s), at no additional cost. The Vendor shall promptly comply with any such instructions for replacement of resources to ensure smooth execution of the services outlined in the contract.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/in terms

of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
