Subject:- Promotion of Accountants to the grade of Sr. Accountant on seniority-cum-fitness basis.

The undersigned is directed to refer to the recommendations of the review DPCs held in concerned Ministries/Departments on the subject mentioned above and to convey herewith approval of the Competent Authority for promotion as Sr. Accountant as per the list enclosed at Annexure- 'A' herewith, in terms of Rule 5(1) & (2) and Column 12 of the Schedule to the then applicable Central Civil Accounts Service (Accountant and Senior Accountant, Group 'C' posts) Recruitment Rules, 2010.

2. The Appointing Authority in the Departmentalized Accounts Organizations may, therefore, issue promotion order in respect of Accountants/Sr. Accountants working in their respective organizations who have been approved for promotion as Senior Accountant as per Annexure-'A' enclosed herewith. While issuing promotion order, it may be ensured that the sealed cover procedure is observed as per the instructions issued by the DOPT vide O.M. No. A.22011/4/91-Estt.(A) dated 14-09-1992, as amended from time to time in the concerned cases.

3. Before issuing individual order, the Appointing Authority may ensure to verify that the particulars of the officials being promoted, as provided to the DPC and to the O/o the CGA in select list, are in order viz, date of joining as Accountant, SSC CGLE Batch, Rank number, clearance of probation period, passing of the Departmental Confirmatory Examination, particulars of the Junior official in case the Promotion is duly approved as per eligibility of the official under Note below Column 12 of schedule to the RRs, etc.
