OFFICE MEMORANDUM

Subject: Open House Sessions on TSA / TSA Hybrid for ensuring smooth closure of Financial Year 2025–26

The Treasury Single Account (TSA) and TSA Hybrid framework implemented through the Public Financial Management System (PFMS) has significantly strengthened transparency, efficiency and real-time monitoring of Government payments across Ministries/Departments.

2. In order to facilitate smooth financial operations towards the closure of Financial Year 2025–26, the PFMS Division has been actively engaging with Ministries/Departments/CNAs/Implementing Agencies to address operational and technical issues relating to TSA / TSA Hybrid implementation.
