## OFFICE MEMORANDUM

Subject: Promotion of Assistant Accounts Officers (Civil) CBT, 2022 passed officials.

With reference to Exam section, OM No. X-11002/2/2022(10834)-EXAM-CGA/1976 dated 11/08/2022 & in terms of Para 17.13.1 of O.M. No. 22011/5/86-Estt.(D) dated 10.04.1089, the present panel for CBT 2022 passed candidates for promotion as AAO will cease to be in force from 15.07.2024. Hence in order to prepare a fresh panel to consider the promotion of AAO (Civil) 2022 passed officials serving in Departmentalized Accounting Organization (DAO) of various Ministries/Departments, the CCAs/CCAs/CAs are requested to furnish the following information/documents in r/o the remaining CBT 2022 passed candidates & in r/o candidates who have forgone their promotion as AAO belonging to their respective DAOs:-

- i) Service Book;
- ii) CR Dossier containing all ACRs/APARs upto the year 2022-23. In case there is any broken period for less than 3 months during the last 5 years, Gap slips for the said periods may be kept in CR Dossiers. While forwarding the CR Dossiers, it may be ensured that it contains all the ACRs/APARs/Gap Slips and none of the ACRs/APARs contain adverse remarks. In case any ACRs/APARs contains adverse remarks, action as required under the relevant rules/instructions of the Govt. of India may be taken before sending the ACRs/APARs to this office. Further, a certificate to the effect that the ACRs/APARs from the period 2008-09 onwards have been seen by the official concerned/disclosed to official concern may also be attached with the relevant ACR/APAR.
- iii) Particulars of the officials in prescribed proforma (copy enclosed). (Pay and Accounts Offices where the candidates are presently posted may send a copy of the proforma complete in all respects directly to this office).
- iv) The information regarding CBT passed candidate who is presently on deputation may also be informed this office.
- v) Certificates of vigilance/departmental cases, penalty etc. in enclosed proforma.

- 2. Promotion of the successful officials will be made in the order of their seniority in the combined Seniority List published by this Office vide OM dated 30.11.2022.
- 3. The provisions of this office O.M. No. A-32014/4/2021/MF.CGA(A)/Group "B"/Policy/HR-III/1463 dated 12.02.2024 regarding the Transfer/Posting Policy of AAOs & Sr.AOs of Central Civil Accounts Service may also be brought to the notice of the successful candidates.
- 4. The Pr. CCAs/ CCAs/ CAs may ensure that above mentioned information/ documents may be furnished to this office by **15.07.2024** positively.
