Subject:- Promotion of Lower Division Clerk to the post of Accountant on seniority-cum-fitness basis (25% quota) for the Vacancy Year 2025 - regarding.

I am directed to invite reference to the provision contained in Rule 5(2) of Central Civil Accounts Service (Accountant Group 'C' post) Recruitment Rules, 2021 on seniority-cum-fitness basis under 25% quota for the vacancy year 2025.

- 2. In this regard, the Departmentalized Accounting Offices in the Ministries/Departments (Civil) are **requested to hold meeting of DPC in respect of eligible officials of their office** who are fulfilling eligibility conditions as per RRs of the post as on 01.01.2025 i.e. the crucial date of eligibility as per DoP&T O.M. No. 22011/4/2013-Estt(D) dated 8th May. 2017.

No. 22011/18/87-Estt (D) dated 09/04/1996, wherever applicable.
- 4. The name of eligible officials for the respective posts may be considered and placed in the select list in order of their inter-se-seniority in the Departmental Gradation List prepared and maintained by the respective Departmentalized Accounting Office, for forwarding to this office in terms of relevant Rule of RRs of the post. The preferences for allocation of STATION as desired in Col. 14 of Sl. No. 6 of the proforma shall be filled in order of priority submitted by the concerned official.
