Subject: Promotion of Accountant to the post of Senior Accountant on seniority-cum-fitness basis for the Vacancy Year 2025 - regarding.

I am directed to invite reference to the provisions contained in Rule 5(2) of Central Civil Accounts Service (Accountant and Senior Accountant, Group 'C' posts) Recruitment Rules, 2010 for promotion of Accountants as Senior Accountant on seniority-cum-fitness basis, for the vacancy year 2025.

- 2.
