Sub.: Nominations of SrAOs for Post Graduate Diploma in Government Accounting and Internal Audit, 2024-25 (16th Batch) at AJNIFM, Faridabad

It is informed that one year diploma programme titled 'Post Graduate Diploma in Government Accounts & Internal Audit' at AJNIFM, Faridabad is scheduled to commence from 17th July, 2024 and would conclude on 16th July, 2025.
