Subject:- Promotion of Multi-tasking Staff to the post of Lower Division Clerk on seniority-cum-fitness basis (5% quota) for the Vacancy Year 2025 - regarding.

I am directed to invite reference to the provisions contained in Rule 5(2) of Central Civil Accounts Service (Lower Division Clerk Group 'C' post) Recruitment Rules, 2010 for promotion of Multi-tasking Staff as Lower Division Clerk on seniority-cum-fitness basis, for the vacancy year 2025.

- Vide this office's O.M. of even No. (302) dated 22.08.2024, the Ministries/Departments 2. were requested to furnish information regarding vacancy position of Lower Division Clerk under seniority quota (5% quota) for the vacancy year 2025 and a copy of Departmental Gradation List of Multi-tasking Staff i.e. feeder grade post, prepared and maintained by the of information received Ministry/Department. The name of eligible officials may be considered and placed in the select list in order of their inter-se-seniority in the Gradation List prepared and maintained by the respective Departmentalized Accounting Office, for forwarding to this office in terms of relevant Rule of RRs of the post.

 - 5.2 A copy of DPC minutes.
