The due date for submission for Sy-II accounts is **6th September 2024.** All the JEs which have been approved by the Finance Accounts Section will be automatically included in Sy-II Accounts of e-Lekha after consolidation of accounts by the concerned PAO in PFMS. Any other corrections, which do not constitute JEs, like corrections at Sub-head, Detailed head and Object head level (if the same was reported incorrectly upto Sy-I accounts, etc.) can also be incorporated in Sy-II accounts.

Pr. Accounts Offices before submission of accounts in e-lekha should verify the data of Pay & Accounts Offices (PAOs) for correctness and ensure that the JE data is incorporated in the Accounts of the concerned PAO. In case of any mismatch in data, support of DAMA Section / GIFMIS Section of this office may be taken.

It is requested to **ensure adherence to this timeline** so that the final accounts for 2023-24 incorporating all the approved JEs and data of any other rectifications carried out, are consolidated and forwarded to C&AG office for clearance in time.
