Subject:- Promotion of Accountant to the post of Senior Accountant on seniority-cum-fitness basis for the Vacancy Year 2025 - regarding.

In terms of Rule 5(1) & (2) of the Central Civil Accounts Service (Accountant and Senior Accountant, Group 'C' posts) Recruitment Rules, 2010, the Accountants in Pay Level 5 are to be promoted as Senior Accountant in Pay Level 6, as per provisions contained in the Recruitment Rules of the post of Senior Accountant.

- 2. The select lists were invited from Departmentalized Accounts Organizations in Ministries/Departments for the vacancy year 2025, vide CGA's O.M. No. NGE-11003/1/2024-NGE-CGA/304 dated 22.08.2024. On the basis of select lists received in this office, the name of Accountants who have been declared 'FIT' and recommended by the DPCs held in respective Ministries/Departments and found eligible for promotion to the post of Sr. Accountant in terms of eligibility conditions mentioned in the relevant recruitment rules on the crucial date of eligibility as per DoPT O.M. No. 22011/4/2013-Estt(D) dated 08.05.2017, have been included in the combined select list prepared in order of their combined seniority as per rules 5(2) of the Recruitment Rules and subject to availability of vacancy in the grade of Senior Accountant.
- 3. Accordingly, the approval of the Competent Authority in Office of the Controller General of Accounts is hereby conveyed for promotion of total 274 Accountants as Senior Accountant on seniority-cum-fitness basis:- (i) 268 Accountants w.e.f. 01.01.2025, (ii) 03 Accountants w.e.f. 01.01.2024 & (iii) 03 Accountants w.e.f. 01.04.2023 as per lists enclosed herewith (List-I, II, & III). Also, 35 Sr. Accountants have been approved for ante-dating promotion as per recommendations of review DPCs held in respective Ministries/Departments and fulfilment of eligibility conditions provided in relevant Recruitment Rules for the post of Senior Accountant, as per lists enclosed herewith (List-IV, V, & VI).
- 4. The LDCs promoted as Accountant on the basis of passing four papers of AAO (Civil) Examination-2014 (later cancelled) shall not be considered for promotion as Sr. Accountant until further instructions as the matter is sub-judiced.

- 5. The Appointing Authority in the Departmentalized Accounts Organizations may, therefore, issue promotion order in respect of Accountants working in their respective organizations who have been approved for promotion as Senior Accountant as per Lists I to VI mentioned in Para 3 above. While issuing promotion order, it may be ensured in the concerned cases that the sealed cover procedure is observed as per the instructions issued by the DOPT vide O.M. No. A.22011/4/91-Estt.(A) dated 14-09-1992 as amended from time to time.
- 6. Before issuing promotion order, the Appointing Authority may ensure to verify the correctness of particulars of the officials being promoted, as provided to DPC and O/o the CGA in the select list viz. date of joining as Accountant, SSC CGLE Batch, Rank number, clearance of probation period and passing of the Departmental Confirmatory Examination, etc. and in case of any discrepancy, it may be brought to the notice of this office immediately before issue of promotion order.
